



**SOUTH FLORIDA REGIONAL TRANSPORTATION AUTHORITY
NOTICE OF A PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the governing board (the “Board”) of the South Florida Regional Transportation Authority (the “Authority”) on **August 23, 2019 at 9:30 a.m. at the Authority’s Boardroom, located at 801 Northwest 33rd Street, Pompano Beach, Florida 33064**, in order to obtain input into the proposed issuance by the Authority of a tax-exempt promissory note and a taxable promissory note in an aggregate principal amount not to exceed \$57,000,000 (collectively the "Note’s”) and the negotiated sale of the Note’s, as identified in the following Authority Resolution:

A RESOLUTION OF THE GOVERNING BOARD OF THE SOUTH FLORIDA REGIONAL TRANSPORTATION AUTHORITY, AUTHORIZING A LOAN IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$57,000,000 FROM TD BANK, N.A. FOR THE PRINCIPAL PURPOSE OF REFUNDING TWO OUTSTANDING LOANS, FINANCING COSTS OF CERTAIN PROJECTS AND PAYING COSTS OF ISSUANCE; AUTHORIZING THE EXECUTION AND DELIVERY OF A LOAN AGREEMENT, A TAX-EXEMPT PROMISSORY NOTE AND A TAXABLE PROMISSORY NOTE TO EVIDENCE THE OBLIGATION OF THE AUTHORITY TO REPAY SUCH LOAN; PROVIDING SECURITY FOR THE REPAYMENT OF THE LOAN; AUTHORIZING OTHER ACTIONS AND DOCUMENTS IN CONNECTION WITH THE LOAN, THE REFUNDING OF THE LOANS AND THE PROJECTS; AND PROVIDING AN EFFECTIVE DATE.

Pursuant to Section 286.0105, Florida Statutes, the Authority hereby advises the public that: if a person decides to appeal any decision made by the Board with respect to any matter considered at its meeting or its hearing, such person must ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. This notice does not constitute consent by the Authority for the introduction or admission of otherwise inadmissible or irrelevant evidence, nor does it authorize challenges or appeals not otherwise allowed by law.
