NOTICE IS HEREBY GIVEN THAT at the Governing Board Meeting of August 25, 2023 the Governing Board for the South Florida Regional Transportation Authority (SFRTA) will hold a Public Hearing at 9:30 A.M. to receive public input on the SFRTA’s intent to file Fiscal Year (FY) 2023 Sections 5307 and 5337 Grant Applications with the Federal Transit Administration (FTA) in the amount of \$52,209,171.
