#### RTA MARKETING COMMITTEE MEMBER COMMMENTS

#### SFCS

- Ms. Brasil shared that SFCS has been in partnership with SFRTA in launching a 3-month pilot with Uber. So far it has been a success as they are seeing ridership increasing.
- Ms. Brasil further shared that SFCS will survey passengers midway and at the end of the pilot to analyze riders' feedback.
- Ms. Brasil shared that SFCS will continue to assist SFRTA with marketing the service
  provided by the pilot program, including sending email blasts, posting on social media and
  station advertising, including a mobile billboard that displayed at the Deerfield Beach and
  Sheridan Street stations.

#### **DTPW**

- Ms. Crichton shared that DTPW is in the process of doing public outreach for the Better Bus Project, to realign all their bus routes.
- Ms. Crichton shared that DTPW is also working on the South Dade Corridor project along, as part of the Smart Plan, which is projected to break ground in April 2021.
- Ms. Crichton shared that as part of the Smart Plan they are also working on the Beach Corridor and the East/West Corridor, where several public hearings are expected.
- Ms. Del Busto mentioned that DTPW has recently opened the first half mile of the underline in Brickell.

#### **SFRTA**

- Mr. Garcia shared that SFRTA continues to promote Tri-Rail services during the pandemic. Having most outreach activities suspended, they are taking advantage of the opportunities to reach people on their devices through mobile advertising.
- Mr. Garcia shared that ridership continues to increase gradually and hopes as more business reopen, more people will come back to using the train.
- Mr. Garcia shared that SFRTA is planning on taking advantage of the airports' drive to bring travelers back to their services, as a way to remind them of the convenience of using Tri-Rail for their travels.
- Mr. Garcia shared that FDOT has granted SFRTA monies for railroad safety outreach, which
  has helped to keep Tri-Rail's services to be featured throughout the pandemic with safety
  videos and digital advertising.
- Mr. Garcia shared that one of the agency's main current projects is the Uber pilot with SFCS, which will help determine how to keep the Commuter Connector service in the future.
- Mr. Garcia further shared that there are three of Tri-Rail feeder routes in Palm Beach County that are being served by Palm Tran, while an agreement is being worked on with the taxi company. The idea is for taxi and Uber service to be provided for all routes. As changes to the program are implemented, passengers continue to be notified with updated messages.
