### I-1. <u>REGIONAL FARE INTEROPERABILITY:</u>

• Mr. Garcia shared that Tri-Rail has received a grant from Broward MPO to develop a Mobile App that will encompass regional fare interoperability. The app will be developed in three phases, and the third and final phase will include a means for each transit entity to install its own payment method without requiring mixing back-office transactions. The project is expected to be completed in the next few years with the collaboration of Miami-Dade, Broward, and Palm Beach mass transit agencies.

#### RTA MARKETING COMMITTEE MEMBER COMMENTS

#### DTPW

• Ms. Crichton shared that DTPW is working on the underline project and the groundbreaking that took place in November 2021 was successful.

- Ms. Crichton shared that DTPW is working with C-Bike, part of the infrastructure with ATMS for signaling when bicycles are approaching. This will allow the traffic light stop signal to know when a bike is approaching, and notify bikers when it's safe to continue crossing the intersection. The testing is being done in Miami Beach.
- Ms. Crichton shared that DTPW is working on updating and repairing the sound barriers on the rail system.
- Ms. Crichton shared that DTPW buses will be moving their access to Golden Glades Station starting January 24, 2022. The busses will return to service the west lot. Bus operators are handing out notices to passengers as they board buses to notify them of change. FDOT is responsible for the ribbon-cutting, but the date has yet been finalized.

## BCT

- Ms. Opperman shared that BCT is reinforcing the federal mask mandate as the CDC's mask mandate was extended.
- Ms. Opperman shared that BCT signage is being created to notify the public that BCT is launching new service changes, effective January 23, 2022.
- Ms. Opperman shared that BCT is working on a regain ridership campaign, which is expected to launch by the end of February through to April 2022.

## <u>SFRTA</u>

- Mr. Garcia shared that SFRTA is waiting on the Golden Glades station opening. Everyone is excited as it's a large parking facility that can help entice ridership growth.
- Mr. Garcia shared that Tri-Rail's Rail Fun Day event is scheduled for February 19, 2022, at the Fort Lauderdale Airport station.
- Mr. Garcia shared that a new marketing campaign was launched and is being called "Part of Your Daily Routine" to help paint a picture of how using public transportation can easily become a part of daily life.
- Mr. Garcia added that SFRTA weekday ridership is averaging 10,000 riders, about 65% of pre-pandemic levels, and hopes the continued outreach efforts will help see it continue to rise.
