I-1. REGIONAL FARE INTEROPERABILITY:

- Mr. Garcia shared that the SFRTA mobile pass sales for the month of August showed a 1% increase compared to the month of July when it started. Mr. Garcia shared that the total sales in August represent 2-percent of total fares for the system.
- Mr. Garcia shared that more signage and collateral is being produced to be placed at stations to make more people aware that purchasing fares on the app is an option.
- Mr. Garcia asked Ms. Salvary if BCT operators are familiar with Tri-Rail mobile passes to
 accept them as valid transfers. Ms. Salvary mentioned that she was unsure so Mr. Garcia
 offered to send information to be shared with operators for this purpose.

I-2 AGENCY INITIATIVES:

• Mr. Garcia shared that FPTA is pursuing a statewide effort to promote public transportation, to help agencies recover passengers lost during the pandemic. SFRTA has committed to support following additional details on how the funds will be used in South Florida.

RTA MARKETING COMMITTEE MEMBER COMMENTS

SFCS

- Ms. Brasil shared that SFCS has officially launched the Uber pilot for service at Golden Glades and the Miami Airport stations. SFCS is currently working on the materials to promote at the stations and through social media, and will repeat the mobile billboard to bring awareness to people in the communities along the corridor.
- Ms. Brasil shared that the St. Thomas University event, which is served by the new Golden Glades service, was successful. SFCS interacted with approximately three hundred students and staff, engaging with them and making them aware of the pilot.
- Ms. Brasil shared that SFCS is preparing for Mobility Week in October, where their outreach efforts will support the entirety of the Ride Partner service.
- Ms. Brasil shared that SFCS will reach out to BCT to organize a bus rider appreciation day to promote the Express service.

BCT

- Ms. Salvary shared that BCT is working on testing a late-shift connect program for riders who work the late-shift to get to and from work after BCT operating hours. The program would provide a taxi service for a \$2 fee, as long as documentation verifying their work hours is submitted from employers. Once employees are approved, they are provided with a pre-loaded card that will allow them to pay for the taxi.
- Ms. Salvary shared that the operating hours are 11:00 p.m. to 6:00 a.m. and it's a one-way ride. Mr. Wilson questioned if there is a cap and Ms. Salvary confirmed that the cap is fifteen dollars.
- Ms. Salvary shared BCT is planning a hiring event on September 30, 2022, at the Lauderdale Lakes venue.

SFRTA

- Mr. Garcia shared that SFRTA started a campaign to promote the Ride Partner service which
 has stemmed a lot of phone calls and social media questions inquiring about how the service
 and vouchers work.
- Mr. Garcia shared that SFRTA is pleased with the enhancement of services in Miami-Dade County, and is hopeful that it will help increase train ridership.
- Mr. Garcia shared that the City of Delray Beach and the West Palm Beach Downtown Development Authority has requested expanding the services in their respective areas, which are currently being reviewed for consideration.
- Mr. Garcia shared that SFRTA has a new Executive Director, David Dech, who is tasked to
 ensure the agency's priority of providing service into Downtown Miami comes to fruition.
 However, since the station does not have an opening date yet, the agency's marketing plan
 will be readjusted accordingly.

- Mr. Garcia shared that what shall remain in the budget is an airport campaign and Tri-Rail's signature annual event, Rail Fun Day in 2023. SFRTA also had advertisement prepared to promote railroad safety during Rail Safety Week.
- Mr. Garcia shared that a meet and greet event is being coordinated with COMTO Fort Lauderdale to introduce the new SFRTA executive director to the public.

FDOT

- Mr. Wilson commented that the BCT late shift program is an excellent idea and there are lots of positive feedback.
- Mr. Wilson shared that FDOT is preparing for Rail Safety Week.
