<u>SFRTA</u>

- Mr. Garcia shared that SFRTA launched its "Airport Campaign" for the 2021 holiday season. Mr. Garcia added that SFRTA has partnered with Spirit Airlines to give away a trip for people who register as part of the campaign.
- Mr. Garcia shared that SFRTA was granted funds to run a pilot with a Microtransit provider, which is expected to start in early 2022. Mr. Garcia added that the provider is Freebee and

the pilot will be for one of the Cypress Creek Station routes that currently serve Holy Cross Hospital.

- Mr. Garcia shared that SFRTA will be participating in the Miami Book Fair.
- Mr. Garcia shared that SFRTA will be holding the South Florida Kids Got Talent auditions on December 11, 2021, at The Galleria Fort Lauderdale.
- Mr. Garcia shared that Tri-Rail's Rail Fun Day will be held on February 19, 2022 at the Fort Lauderdale Airport Station, potentially in the parking garage. Mr. Garcia added that SFRTA is partnering with additional local events to promote service, including the Lake Worth Street Painting Festival and possibly Ultra Music Festival.
- Mr. Garcia added that SFRTA weekday ridership is averaging 10,000 riders and hopes it will continue to grow.

## <u>SFCS</u>

- Ms. Brasil shared that the FAU event and Lake Worth is coming up and would be happy to have SFRTA join with SFCS.
- Ms. Brasil shared that the pilot program is running smoothly and also there is a survey that will be going out from Uber to everyone that has downloaded the voucher. Ms. Brasil added that mobility week was very successful.
