Have any of the transit properties in South Florida explored the creation of a Bus Buddy Program? Bus Buddy would be a community initiative that facilitates individuals connecting with each other through an online matching database to explore and use public transit together. Participants may sign up, create profiles, and find compatible bus buddies based on shared routes or schedules. # **SFCS**

• Ms. Hanning commented that the SFCS team were disappointed that they did not receive an invitation to the Tri-Rail Miami Central opening. Mr. Garcia apologized to SFCS, as it may have been an oversight on the distribution list when sending out the invitations. Mr. Garcia will check and reach out to SFCS team.

# Palm Tran

- Mr. Henderson shared that Palm Tran is currently working on the champion marketing project that is expected to launch on March 1, 2024. The idea of the champion marking is to encourage people to use public transportation and try Palm Tran. It was the idea of the previous Palm Tran director, and Palm Tran wants to continue with his legacy.
- Mr. Henderson shared that Palm Tran is looking for support among the different inferential leaders in Palm Beach county, as well as sending out invitation to meet with elected leaders, business owners within the community to assist with any challenges.

- Mr. Henderson shared that leaders and business owners will have the opportunity to ride with the Palm Tran executive team to their favorite location on one of the Palm Tran routes. As well as a 3-month pass to anyone on the champion team.
- Mr. Henderson extended the invitation to the group for support.

### **FDOT**

• Mr. Newton shared FDOT is making a push for employee engagement in riding transit.

### **WPBGO**

- Mr. Harrigan shared that WPBgo pilot program is in the final stage and hoping to share with the public.
- Mr. Harrigan shared that WPBgo has launched their new website and it's a great tool to access TVM benefits that are available in the City of West Palm Beach.
- Mr. Harrigan shared that Palm Beach has joined the partnership coalition that aims to address the traffic and congestion challenges in and around West Palm Beach area.

#### **SFRTA**

- Mr. Garcia shared that SFRTA Tri-rail has finally got the good news that they were allowed
  to start service in Downtown Miami Central, the team quickly prepared for the opening
  ceremony.
- Mr. Garcia shared that Tri-rail is currently running trains from the Metro-rail transfer station into Miami Central and back. SFRTA started off with a soft launched by running 6 trains and will increase until there is a full set of 26 trains during the week days which is anticipated to start on January 27, 2024.
- Mr. Garcia shared that the team is gathering collateral that will be available to the public. As well as staff members are at the stations proving the public with information. As soon as collaterals are available, SFRTA will reach out to partners for their support in handing out information. The broward MPO is willing to partnership in this effort.
- Mr. Garcia shared that Tri-rail is incrementally adding trains, as the schedule changes during the soft launch. The operation team is looking at few things, with the possibility of making adjustment to the schedule and plan accordingly to the start of full service.
- Mr. Garcia shared that coming soon videos was shared on the website and will share with the group. The focus is on the community outreach and safety, importantly reminding the public to be safe around trains. There are signs during testing of the trains as well.
- Mr. Garcia shared that Tri-rail is planning a yearly rider play campaign that connects with different partners, to encourage people to use the system. The Tri-rail website app has been updated.
